

Trends in race and ethnicity, age, and language should help shape policy and planning decisions and fine tune regional goals. Looking at demographic trends will enable the plan and stakeholders to better address the needs of all communities.

# ON TO 2050 will reflect metropolitan Chicago's changing demography.

CMAP is currently collecting and analyzing demographic data to inform the next plan, as well as ON TO 2050 outreach and implementation efforts. For instance, we know the region is diversifying, with recent population growth being driven primarily by persons of color. These shifting demographics have implications for regional and local planning. Racial and ethnic groups may hold varying preferences and face different challenges in housing, transportation, education, employment opportunities, and other factors that impact quality of life.

In addition to exploring the above findings, the upcoming Demographics Snapshot report will include analysis of socioeconomic characteristics such as educational attainment, employment, and income, which will be integral to ON TO 2050's strategies. Comparing these trends to peer metropolitan areas will also provide a perspective on the region's continued vitality and economic success.
