A representative of IDOT District 1 will discuss innovative roadway designs -- such as diverging diamonds and roundabouts -- and considerations for truck traffic.

CMAP staff will discuss a forthcoming task force that is intended to collaboratively set priorities and investments that can help take advantage of emerging mobility technologies, including connected and automated vehicles, smart infrastructure, transportation network companies, ITS, and shared mobility services. Staff will present the goals of the project and request feedback on how the task force can incorporate freight considerations.
- 6.0 Truck Route Designation Legal Changes**
Recently enacted changes to Illinois statutes impact the legal framework for truck routes and restrictions. Staff will discuss these changes – which were enacted in [Public Act 100-0343](#) (effective January 1, 2018) and [Public Act 101-0328](#) (effective January 1, 2020) – as well as their impact on CMAP’s forthcoming truck routing studies and on communities generally.

Staff will provide an update on this recently launched study, which will build on existing freight planning efforts to identify appropriate truck routes in the freight hub of western Will County.

Staff will present freight information available on the CMAP web site.
